We achieve our mission by providing individually tailored service to people with intellectual, developmental, and physical disabilities throughout the region. Our services are available to people living in their own home, their family's home, or in one of our 34 group homes. We work towards a day when all people impacted by disabilities live well.

**Form 990, Part III, Line 3, Changes in Program Services:**

COVID-19 has adversely affected all nonprofits, but its impact on the Disability Services sector has been disproportionately large. Due to the physical and medical vulnerabilities of the people we serve, normal operations at LWDS have been significantly altered.

Impact on people we serve: As part of their pre-COVID day routine, most of the people we serve went to Day Service providers where they performed jobs suited to their skills. This provided them with a sense of purpose and some monetary reward. Almost all these day service providers closed due to COVID, and we had to provide alternative day services in our homes using temporary staffing. Visits from birth family were a treasured part of the lives of the people we serve.

These had to cease due to social distancing guidelines introduced by the State of MN. Similarly, community activities such as going to parks, libraries, and ball games also stopped. This has created gaps in the social lives of the people we serve, and we have working hard to find alternatives.

Impact on Gala: Our normal fundraising special event, the Annual Gala, was converted from a large in-person gathering to a virtual one, which was a missed opportunity for all the Living Well stakeholders who wait for this the whole year. Similarly, the Annual Family Fun Day which is held in a local park also had to be cancelled.

Uncertainty and volatility: Due to the closure of day service programs, LWDS had to take over certain daily program activities and related expenses to fill the gap. This introduced unprojected revenue and expenses to the financial picture. However, we were able to quickly adapt to the evolving crisis and made alternate plans. LWDS is grateful that it was still able to maintain all the basic services for most of the people we serve.

Positives that have stemmed from the pandemic: There was a significant rise in the number of volunteers who provided many services such as cooking freezer meals, prepared PPE equipment, and making deliveries to homes. The administrative functions of Living Well also were able to increase their knowledge and sophistication in the use of remote technology to conduct business operations. This is a good thing for us as the business models gradually moves toward office/remote work hybrids.

Preparing for the future: As the COVID-19 appears to be slowing down and vaccinations percentages are increasing nationwide, Living Well is looking forward to and preparing for a return to a new normal, where we would be getting back closer to our normal operations.
