Form 990, Part III, Line 3, Changes in Program Services:

In 2021, COVID-19 continued to adversely affect Living Wells operations and the services it provides to the people it serves. Due to the physical and medical vulnerabilities of the people we serve, normal operations at LWDS have continued to be altered.

Impact on people we serve: As part of their pre-COVID day routine, most of the people we serve went to Day Service providers where they performed jobs suited to their skills. This provided them with a sense of purpose and some monetary reward. In 2020, almost all these Day Service providers had closed due to COVID, and we contracted with day program staff to come into the homes to provide alternative day services which promoted consistency and familiarity for people served. In 2021, several Day Service providers re-opened and several of our people served have started to return to the Day Service provider locations. Visits from family and friends were a treasured part of the lives of the people we serve. In 2021, some of these visits from family have resumed and several people have started to return to the Day Services. These had to cease due to social distancing guidelines introduced by the State of MN. These family and friends visits have also gradually resumed which has helped the people served. Finally, last year, community activities such as going to parks, libraries, and ball games had also stopped, creating gaps in the social lives of the people we serve. We had worked hard to find alternatives for these activities. This aspect of social life has also returned to a great extent and people are going back to parks, libraries, and ball games.

Impact on Gala: In 2020, the first year of COVID, we had to convert our normal fundraising special event, the Annual Gala, from a large in-person gathering to a virtual one. This was a missed opportunity for all the Living Well stakeholders who wait for this the whole year. However, in 2021, we were able to hold a Gala event which was a hybrid between virtual and in person gatherings. The event was streamed online for people who could not attend in person; however, there was a physical gathering where donors and other stakeholders met and were able to share a meal and comingle. In 2021, the Annual Family Fun Day was scheduled but had to be cancelled due to extremely hot weather.

Uncertainty and volatility: The financial picture continued to be volatile and uncertain during 2021. In 2020, due to the closure of day service programs, LWDS had taken over certain daily program activities and related expenses to fill the gap, which resulted in a significant amount of unprojected revenue and expenses to the financial picture. In 2021, this uncertainty subsided a little but did not disappear. This year, unbudgeted Day Service revenue continued to add unbudgeted revenue and expenses.

Positives that have stemmed from the pandemic: People have continued to volunteer to provide services such as cooking freezer meals, preparing PPE equipment, and making deliveries to homes. However, the number of volunteers decreased from 2020, when COVID was at it most severe level. Most administrative functions of Living Well also continued to be performed via remote technology but an increasing number of staff were visiting their offices in person to connect with other staff members.

Preparing for the future: As 2021 ended, most of Living Wells' staff and people served had been vaccinated and received booster shots. It is expected that towards the early months of 2022, a hybrid work model will emerge, mixing the benefits of remote and in-person collaboration.

Well trained, full- and part-time staff provide exceptional individualized support so that each person can live well. Living Well Disability Services, serves a broad spectrum of people with intellectual, developmental, and physical disabilities such as cerebral palsy, Down syndrome, multiple sclerosis, autism, and brain injury. These may be complicated by health issues related to aging, diabetes, Alzheimer's, medical fragility, and other chronic Health conditions. We also support people who have dual diagnoses of intellectual disabilities and mental health concerns.
