In 2022, although COVID-19 did not disappear, its impact on Living Well's operations was less severe than that in earlier years. It continued to adversely affect Living Wells operations and the services it provides to the people it serves. Due to the physical and medical vulnerabilities of the people we serve, normal operations at LWDS have continued to be altered.

Impact on people we serve: As part of their pre-COVID day routine, most of the people we serve went to Day Service providers where they performed jobs suited to their skills. This provided them with a sense of purpose and some monetary reward. In 2022, some of these Day Service providers had re-opened due to the weakening of the COVID virus and the people we serve were able to resume visting the Day service. Visits from family and friends, which were a treasured part of the lives of the people we serve, also increased in 2022, as the social distancing guidelines from the state of Minnesota were relaxed. Finally, in 2022, other community activities such as going to parks, libraries, and ball games had had also resumed, creating a positive impact on the quality of life of the people we serve.

Impact on Gala: In 2021, we held a Gala event which was a hybrid between virtual and in person gatherings. The event was streamed online for people who could not attend in person; however, there was a physical gathering where donors and other stakeholders met and were able to share a meal and comingle. In 2022, we returned to the usual in

person format and the annual Gala was held fully as an in-person event and met our fundraising goals. The event was also streamed online as in the last year. In 2021, the Annual Family Fun Day was cancelled due to weather; but in 2022, the Family Fun Day was held in its usual joyous manner in an outdoors park in the Como neighborhood.

Uncertainty and volatility: Compared to pre-COVID years, the financial picture continued to be uncertain during 2022. In 2022, certain expenses were significantly higher than 2021. The extreme shortage of staffing put Living Well in a place where it had to offer several salary augmentations to the regular staff to work in certain homes. Despite strong recruitment efforts, staff vacancies forced us to use staff from Temporary agencies and it created a significant unbudgeted variance in our staffing costs.

Positives that have stemmed from the pandemic: People have continued to volunteer to provide services such as cooking freezer meals, preparing PPE equipment, and making deliveries to homes. After working mostly in a remote fashion, most administrative functions of Living Well have started to shift to a hybrid model, where all staff members are working, in person, at the office a few days a week.

Preparing for the future: As 2022 ended, Living Well had experienced one of a few years where net operating losses were experienced. The leadership team studied the reasons for this in depth and a deficit-reduction plan was created. This plan was approved by the Board of Directors, and we look forward to implementing it in full and returning to a more profitable net operating income level.
